#### Meeting started 12:08

- Approval of February 19, 2016 minutes.
   Motion to approve the minutes, seconded, and approved.
- II. Need for D1/D2 to D3 transition meeting Drs. Tad Mabry & Trishul Allareddy
  - The need for this type of meeting was briefly discussed. There is a sense that feedback is already given interdepartmentally from D2 to D3 years among faculty and a formal meeting or information from other departments would not be that beneficial. Most often same faculty are teaching in the D2 and D3 years within a department and are aware of any student issues. Also, there may be too much of a gap for useful information between D1 and D3 year.

- III. Grading rubric presentation guidelines Dr. Tad Mabry
  - For the May meeting, Dr. Mabry is requesting that each clerkship director present their rubrics to the committee. This will help us determine how or if we can standardize clerkship grading.

Action Item: Each member should be prepared to present their department's clerkship rubrics for the next meeting. Clerkship Directors that will not be present at the May meeting should assign someone from their department to attend and present the grading rubric. Please send an electronic version of your clerkship rubrics to Dr. Mabry & Michelle Krupp by May 13th.

- IV. Summary of StartCheck Survey Dr. Tad Mabry/Ms. Michelle Krupp
  - Ms. Krupp presented the results of the Clerkship Director Survey regarding start checks. Please see handout for results.

- Startcheck documentation can be created so all these items can be automatically pulled into one page. It is still important that students review the information before presenting patient to faculty.
- Points of information that could be standardized/required were discussed.
   Based on the results, Dr. Mabry identified 5-6 areas that he will follow-up on to see how they can be incorporated into StartCheck. Oral Diagnosis can then 'pilot' StartCheck in July.

ACTION ITEM: Tad Mabry, Jerry Gehling & Joni Yoder to begin draft document in StartCheck by June meeting. Have Oral Diagnosis 'pilot' in July before clerkships start. Place this topic on the JUNE agenda.

### V. Comments/Updates - Committee

- Dr. Mabry stated that the May meeting will primarily focus on the Clerkship Rubric presentations given by each clerkship director.
- Students asked if there is a way in AxiUm for faculty to know when patients are ready to be seen. Currently, it is difficult for faculty to determine which patients were ready first when all they see are lights on. This causes patients and students to wait longer.
- Dr. Handoo requested that in all clerkships if patients have outside radiographs can you please make sure they get scanned and sent to Central Records?















## Q4: CHIEF COMPLAINT (Select where a student will obtain the chief complaint)






