Meeting called to order – 12:03 p.m.

- I. Motion to approve HTC minutes of the February 10, 2016 meeting passed.
- II. Updates- Mr. Ivan Medin & Dr. Lily Garcia
  - True Definition Scanner Integration Everything is in place but waiting for the business agreement. Once the agreement is finalized, True Def will be online and ready for use.
  - DSG services for College DSG visited COD last week. The Dental Laboratory Technicians (CDTs) will meet with Dr. Garcia to review responsibilities. DSG suggested trial usage in order to understand the workflow and assess the quality.
    - Dr. Garcia emphasized that use of DSG services will not replace our local affiliations, only enhance our laboratory support.
  - Maintenance Costs With recent purchases, the COD receives the CEREC/Sirona "Club" at no cost; this includes limited training, maintenance, and software updates. However, the renewal cost is \$10,000 so other maintenance options are being explored.
  - PlanMeca/E4D: Two scanners are broken and replacements have been ordered.
    - Mr. Medin commented that he is noticing that the E4Ds require more maintenance. Concerns arise after being left "on" for extended periods of time. The COD is an 'industrial'-use environment associated with our studentpopulation volume use.

- III. Onsite Training Opportunity Dr. Erica Teixeira
  - CEREC/Sirona is sponsoring Dr. Richard Fox March 21-22, 2016
    - o March 21 focus will be on basic training, all day session
    - March 22 focus will be more advanced training, i.e., software updates. Two repeated sessions will occur in the am & pm on this day.
- IV. Online Training Opportunity Drs. Marcos Vargas & Lily Garcia
  - 3m True Definition Live webinars are available for faculty. Dr. Teixeira requested

that committee members tell their departments about this <u>free</u> training opportunity. ACTION ITEM: Committee members distribute info/flyer that was sent with today's agenda to colleagues.

V. Update: Clinic Operations Manual – Ch. 4 Infection Control – Dr. Erica Teixeira

- CEREC changed infection control protocol; recommend use of CaviWipes. CEREC continues to modify disinfection/sterilization protocol, which is posted on the machines.
- VI. Other
  - Dr. Garcia initiated discussion regarding the costs and types of maintenance for scanners. The misuse of the equipment was briefly discussed. Mr. McBrearty suggested that we need to follow company protocols, educate/inform students and faculty, and determine if problems are caused by the users or faulty equipment. Key points that need to be further discussed:
    - o Systems might not be able to handle 'industrial' use.
    - Should there be consequences of misuse? Should students be held accountable for misuse, i.e. technical fee prorated, tied to grades, etc.
    - Committee needs to decide if we need multiple systems would it be beneficial to just have one system or do we need multiple?
    - Scanners & software are used for assessment. Have to consider how course directors are using the system.

ACTION ITEM: Develop tutorial how to use digital scanners with caveat that if you are not trained, you cannot use. Mr. Medin will continue to keep track of maintenance trends then Dr. Garcia can follow-up with companies with specific details.
