Meeting called to order 12:05

 Approval of December 16, 2019 minutes – Dr. Allareddy MOTION: to approve the minutes as submitted and seconded. MOTION APPROVED.

II. Resident Wellness Orientation – Ms. Cari Anderson

Ms. Anderson gave a brief snapshot of her services during past orientations; however, more residents are seeking her services. She would like to give a more detailed overview as she currently gives D1 students during a noon conference sometime in the month of July. The committee members agreed that this should be a required session. Date is TBD.

III. New Resident Orientation Draft Schedule – Dr. Krupp/Ms. Selck

Dr. Krupp discussed the tentative New Resident Orientation schedule this year.

- The program director panel will be shorter with each program director giving their residents a tour after the panel.
- Dr. Denise Martinez will return this year to present Cultural Responsive Care.
- Dr. Butali will present Ethics & Professionalism again this year. This will satisfy one of the CODA standards.
- Library Services, Oral Science Introduction and IT Policies and Procedures will follow on that first day of orientation.
- Residents will end the first day with pictures and HR Topics.
- The second day will start a bit later and will be more clinical presentations.
- Dean Timmons will be out during orientation and will present at a later date.
- Presenters will be requested to have a handout for any informative sessions. These handouts will be made available on the Intradent in a new resident orientation section.

It was discussed that PhD students only need to attend the first day of orientation.

IV. <u>Conflict Resolution</u> – Dr. Allareddy (Presentation)

Dr. Allareddy contacted program directors from multiple specialties in multiple institutions. He found that a majority of the schools do not have a policy regarding conflict resolution.

The attached presentation shows the levels of conflict that are a possibility and the suggested steps to resolve the conflicts. There is currently no written policy but these steps are generally followed. Dr. Allareddy will circulate the draft and work closely with the Offices for Education and Student Affairs before finalizing.

VI. Roundtable Comments

- Dr. Leary mentioned that Dr. O'Connell from the International Association of Dental Traumatology will be here on March 23 at CDD from 10 to 11:30. Dr. Leary will be sending out emails with additional information.
- Dr. Leary also discussed how the D3s do a poverty simulation prior to starting the clerkships. During this simulation, each individual is given an identity and they simulate a month in poverty. This is a very robust kit that costs about \$3000 and the CoD has been doing this for about 3 years. The LEND Training program does the same exact poverty simulation on Friday which the CoD Pediatric dental residents will be participating in. This would be a great opportunity for other residents, especially international residents as part of the simulation discusses Medicaid, the different layers for applying for social services, for housing, for transportation and how to navigate the system. This is very powerful, especially for people who are not from the United States. The Dental School training is on Thursday afternoon and the LEND training will be on Friday morning. If anyone is interested in getting more information, please contact Dr. Leary.




