#### IV. Fall Plans - Interviews, Courses, Clinic - Committee

#### V. Roundtable Comments - Committee

- Dean Timmons discussed a notice sent out by the University to all students including residents and graduate students that requires them to complete an ICON compliance course for student acknowledgment regarding the student responsibilities for COVID. This was due on Friday, August 21. The University will contact the Office of Student Affairs if there are any students who are not compliant.
- Dean Timmons would like to send out a set of recommendations which reinforces the College of Dentistry's expectations as a College for students on campus in regard to face masks and screening as well as their responsibilities after hours of wearing a mask while on the premises. Included in these recommendations is highly encouraged recommendations of behavior off campus which emphasizes wearing a mask, social distancing and hand hygiene.
  - The Advanced Education directors have agreed to have Dean Timmons send out these recommendations to the residents and graduate students at the College of Dentistry.
- The Advanced Ed programs have chosen to report any resident positive COVID tests or high risk exposures to Dean Kanellis in Clinic Administration for contract tracing. Clinic Admin as well as Dean Timmons and Dean Krupp are required to report to the University.

#### **Advanced Education Committee**

Appointment by position: Program director of the advanced education and graduate programs will be appointed automatically; if an assistant or coprogram director exists for a program, voting privileges will reflect one vote per program. The committee will work to improve and advance excellence in the postdoctoral education programs of the College. The committee will communicate advisory reports to the Associate Dean for Education. In order to fulfill this charge, they will:

- 1. Advise the administration, through the ADE, on liaison activity which will assist in the support of the above effort for excellence;
- 2. Develop policies and mechanisms which can be utilized for the benefit of any or all programs such as dismissal policies, admission procedures and elective courses which can benefit two or more programs;
- 3. Work to enhance the interdisciplinary education across specialties and programs.
- 4. Share informational resources to avoid duplication of efforts and in support of streamlining mandatory reports.
- 5. Monitor student progression through the educational programs.
- 6. Work in concert of the resolution of recommendations from the Council on Dental Education and the Graduate College for the improvement of the collegiate programs.


- How to effectively and accurately identity patients with a high risk to development systemic complications in dental offices (1 hr)
