Curriculum Committee Minutes – February 5, 2020

Meeting called to order 12:03 p.m.

- Approval of January 15 Minutes; Dr. DC Holmes

- II. <u>Critical Thinking/EBD Presentation</u> Work Group (Presentation)

 CT/EBD work group members, Drs. Tad Mabry, Satheesh Elangovan, Nidhi Handoo,
 Leonardo Marchini, and Ms. Katie Wolter (D2) have been meeting over the last three
 months to review the collegiate EBD/CT curriculum thread as well as identify and make
 suggestions for improvement.

Dr. Mabry gave the presentation on the group's findings. He described the process as being one that does not define but puts meaning into how the CoD wants their students to practice evidence based dentistry and critical thinking.

Please refer to the attached presentation for more details on considerations, goals and learning objectives discussed during the meeting.

Comments/Questions:

- This work group's charge was a huge undertaking and this presentation was very well done
- This is the first time we have reviewed a curriculum thread.
- There is an emphasis on coordination of learning throughout the four years as well as relevance and application of the clinical side.
- Moving forward, there will need to be further discussion regarding the D3 year since the D3 Critical Thinking course was deleted as a result of Title IV compliance. With no dedicated critical thinking class, clerkship directors will need to teach and assess the outcomes related to both critical thinking and EBD. Further discussions will create an opportunity for the Curriculum Committee to collaborate with the Clerkship Directors Committee.

Dr. Marchini, the new D2 critical thinking course director, has been working closely with Dr. Caplan to develop a course focused on critical thinking in treatment planning. Dr. Marchini would like this new course to be a continuation of the D1 course. He feels that it would be important to transfer into the D3 course with the same idea so that it will be familiar to the students.

Comments/Recommendations:

 Appreciative of Dr. Marchini, as it will be a challenge to create this course from scratch but it will also create opportunities to bridge these courses. Recommend that Dr. Marchini meet with the Clerkship Directors to determine what their expectations are. It is most essential to create that bridge from the D2s to the D3s.

III. <u>GSN-FAMD Update</u> – Dr. Holmes

Drs. Holmes, Cowen, Hartshorn and Caplan have had ongoing discussions and agreed that Option 3, as outlined in Drs. Cowen, Hartshorn and Caplan presentation at the last committee meeting will be implemented for a year as a transitional phase. This option includes:

- Seven D4 students to be assigned to each of the 8 extramural GSN blocks, which would count for 56 students. The remaining D4 students would attend GSN instead of FAMD for the same day of each week for 10 consecutive weeks.
- Clinical procedures completed by D4 students in the non-extramural GSN Clinic assignment will be counted towards FAMD MEEs and RVUs.
- GSN faculty supervising the non-extramural students will provide input to the students' group leader for coaching/feedback and final grading.
- Supervising faculty in the GSN clinic will be able to be released from their other assignments in order to participate in all of FAMD Faculty Conference activities (calibration, continuing education, reviews of individual student progress).
- These special provisions should be explained clearly too all students prior to the submission of their extramural preferences and will be reiterated with a brief orientation prior to the beginning of the D4 year.

Based on outcome data that supports number of days necessary to achieve intended learning goals, a revised arrangement could be developed for the subsequent year that would meet the following goals:

- Every D4 student will participate in the same GSN Clinic experience for an approximate equivalent number of days.
- Clinical procedures completed by D4 students in the GSN Clinic under supervision of CoD faculty will be counted towards Family Dentistry MEEs and RVUs.
- Supervising faculty in the GSN Clinic will participate in all Department of Family Dentistry Faculty Conference activities (calibration, continuing education, reviews of individual student progress)

IV. <u>Title IV Impact</u> – Dr. Krupp (handout)

Dr. Krupp provided a handout that shows which courses were impacted by the Title IV mandate. Eight courses were split to create 12 new courses (highlighted in blue), 6 courses moved into 1 semester, 4 courses were combined and 1 course was deleted. This has exploded the curriculum and expanded semester hours. Dr. Krupp suggests doing a curriculum analysis to look methodically at all components, interrelatedness, inefficiencies and overall effectiveness.

V. Integration Retreat – Dr. Krupp

The integration retreat will be held on February 26, 2020 at the Radisson Hotel in Coralville. This daylong event will focus on generating recommendations for integrated teaching, learning & curriculum. There will be a heavy focus on collaboration between clinical and biomedical science faculty.

Dr. Ellen Byrne, Academic Dean, from Virginia Commonwealth University will skype in to speak about the boards and what they do at VCU.

A patient box question development session will be done at the end of the day with the idea that eventually all of the CoD faculty will be trained on how to develop patient box test items.

More information will be sent out at least 2 weeks before the retreat.

VI. Round Table Comments – Committee

- Mr. Layton Fritsch (D4) asked how the RVUs will be assigned for those students who go to GSN? Will it be per procedure?
 - Dr. Holmes responded by saying it will be per procedure, but will only be for the 24 students who do this during FAMD. Rather than a student doing 8 consecutive days in GSN Clinic, it would be a day a week for 10 consecutive weeks. This will hopefully let students do procedures from start to finish rather than an isolated part of a procedure.
